## SUMMARY ANNUAL REPORT

### ANNUITY FUND OF LOCAL NO. ONE, I. A. T. S. E.

This is a summary of the annual report for Annuity Fund of Local No. One, I. A. T. S. E., EIN 13-3022965, Plan No. 002, for period January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic Financial Statement**

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$60,114,355. These expenses included \$1,072,841 in administrative expenses, \$58,692,020 in benefits paid to participants and beneficiaries, and \$349,494 in other expenses. A total of 19,884 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$956,229,543 as of December 31, 2022, compared to \$1,131,798,023 as of January 1, 2022. During the plan year the plan experienced a decrease in its net assets of \$175,568,480. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of (\$115,454,125), including employer contributions of \$43,871,245, employee contributions of \$272,972, rollover contributions of \$576,606, earnings from investments of (\$160,824,948), and other income of \$650,000.

#### **Minimum Funding Standards**

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

- an accountant's report;
- financial information;
- information on payments to service providers;
- assets held for investment;
- fiduciary information, including non-exempt transactions between the plan and parties-in-interest (that is, persons who have certain relationships with the plan);
- insurance information, including sales commissions paid by insurance carriers;
- information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates;

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
