# Mental Health and Wellness

32% of Local One participants have been diagnosed with a mental health issue, and that number continues to rise.



That's much higher than statistical norms, and reflects the very real stresses associated with living the life of a Stagehand. Those stresses often contribute to anxiety, depression and other issues that could affect both you <u>and</u> your family.

In the past few years, Local One's wellness program focused on physical health. We've worked on the lifestyle challenges, like diet and exercise, that could help prevent illness. But the concept of "Wellness" – actively taking charge of our health and working to stay healthy – also applies to our mental health. In truth, physical and mental health directly impact each other, and we have to manage both to stay "well".

With the hire of Nneka Symister, Local One's new Healthcare Coordinator (see profile inside), we want to expand the conversation about Wellness to recognize the importance of mental health, and how it affects our physical health. Nneka will offer us the perspective of a healthcare professional with extensive experience dealing with both mental and physical wellness, and she will be an important resource to you if you need assistance with any aspect of your healthcare.

## Substance Rehabilitation Incentive Program

Addiction requires treatment like any other chronic disease. Rehabilitation (rehab) centers offer a level of treatment for substance use that falls between the intense medical care of inpatient hospitalization and the independence of outpatient treatment.

While there are many reputable rehab programs available, this relatively under-regulated industry has been plagued in recent years with programs, mostly centered in Florida, involved with various fraud schemes, including unethical marketing, patient brokering and insurance fraud. These out-of-network programs provide questionable treatment for participants, and can cost the Welfare Fund 5 to 10 times the cost of a quality in-network rehab program.

Trying to find a good, quality rehab program that will provide the services and amenities that you need while also establishing a sustainable outpatient plan can be overwhelming. But you don't have to do it all alone. The Welfare Fund, working in conjunction with The Actors Fund Participant Assistance Program, has established an incentive program designed to assure that Local One participants find quality rehab programs that match their needs.

#### **HOW IT WORKS...**

Participants who meet Aetna's medical necessity guidelines for inpatient rehabilitation and successfully complete their treatment plan at a preferred facility will receive:

- \$1,000 Credit against future Self-Pay Premiums, and
- \$0 cost sharing for in-patient and intensive outpatient treatments.

Participants will be required to arrange for treatment through The Actors Fund or Local One's Healthcare Coordinator, Nneka Symister. Crediting will be made after the successful completion of intensive outpatient treatment, as determined by The Actors Fund.

### WELLNESS INCENTIVE DEADLINE

We are fast approaching the end of the year and you only have a few months left to qualify for the **\$400 wellness incentive**. If you are a participant with active coverage, you can qualify for the incentive starting January 2020 by ensuring that you and your covered spouse complete your annual wellness exam by the end of 2019. To ensure that you receive your credit at the time your self-pay premium payment is due on or before 1/01/2020, please have your exam completed by **10/31/2019**.

If you don't have a primary care physician or you're unable to visit your physician by the end of the year, please remember that Local One's medical home —**The Friedman Center** — is conveniently located in the theater district and there are **NO COPAYS for primary care visits** for participants with active coverage!

## Self-Pay Premiums are Due October 1st.

## Late Payers will be <u>Terminated</u> October 31st!

If you don't get your self-pay premium in or postmarked before 10/01/2019, you will be subject to the \$25 late fee. Much worse than that, if you miss the 10/31/2019 deadline, you will lose your coverage!

Please don't take any chances losing this very valuable benefit.

Remember to make your payment ON TIME!

## Have you Moved? Changed your Phone or Email?

People also lose their Welfare Fund provided health insurance when they forget to update their mailing address and phone number with the Fund Office. The fact that you didn't receive the invoice and reminders because you didn't update your contact information is not an acceptable excuse. As a participant in the Fund, you have an obligation to keep your contact information up to date at all times, both here at the Fund Office, and also at the Union.
