

SUMMARY ANNUAL REPORT
For WELFARE FUND OF LOCAL NO. ONE I.A.T.S.E.

This is a summary of the annual report of the Welfare Fund of Local No. One I.A.T.S.E., EIN 13-6174166, Plan No. 501, health plan, for period July 1, 2021 through June 30, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Board Of Trustees of Welfare Fund of Local No. One I.A.T.S.E. has committed itself to pay certain claims incurred under the terms of the plan.

Insurance Information

The plan has a contract with HCC Life Insurance Company to pay stop loss claims incurred under the terms of the plan. The total premiums paid for the plan year ending June 30, 2022 were \$2,186,125.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$28,106,275 as of June 30, 2022, compared to \$18,732,054 as of July 1, 2021. During the plan year the plan experienced an increase in its net assets of \$9,374,221. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$43,856,781, including employer contributions of \$41,467,415, employee contributions of \$3,471,979, realized losses of (\$703,689) from the sale of assets, earnings from investments of (\$472,864), and other income of \$93,940.

Plan expenses were \$34,482,560. These expenses included \$1,328,929 in administrative expenses, and \$33,153,631 in benefits paid to participants and beneficiaries.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (Board of Trustees of Welfare Fund of Local No. One I.A.T.S.E., 320 West 46th Street, New York, NY 10036) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
