**Summary Annual Report
for
WELFARE FUND OF LOCAL NO. ONE, I.A.T.S.E.**

This is a summary of the annual report for the WELFARE FUND OF LOCAL NO. ONE, I.A.T.S.E. (Employer Identification No. 13-6174166, Plan No. 501) for the period July 1, 2009 to June 30, 2010. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$33,969,887 as of June 30, 2010, compared to \$32,646,340 as of June 30, 2009. During the plan year the plan experienced an increase in its net assets of \$1,323,547. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$33,807,503. This income included employer contributions of \$26,466,672, employee contributions of \$2,699,084, earnings from investments of \$3,912,637, and other income of \$729,110. Plan expenses were \$32,483,956. These expenses included \$944,111 in administrative expenses and \$31,539,845 in benefits paid to, or on behalf of participants and beneficiaries.

2. Insurance information including sales commissions paid by insurance carriers.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. These portions of the report are furnished without charge.
